- (a) provide copies of their identity documentation as outlined in the Verification of Identity Minimum Document Requirements; and
- (b) the Australian Embassy/High Commission/Consulate Identity/Witnessing Certification to be completed by the witness that witnessed that borrower's signature at the Australian Consulate / Embassy Office.

Please note that we can only discuss matters relating to the discharge of your loan with you or your representative nominated on the Discharge Authority.

Settlement Date

Once the completed Discharge of Authority form and the documents required to verify your identity has been returned to us and processed, we will instruct our solicitors to prepare the discharge of mortgage over your property. Our solicitors will contact either you or your nominated representative to arrange settlement. Once the settlement date has been confirmed, a payout figure will be provided no later than the day before the scheduled settlement date.

Please note that we require at least 15 business days' notice to arrange settlement. If the Discharge of Authority form and the documents required to verify your identity has not been returned to us timely or there are any errors, settlement may be delayed and we will not be liable to you for any loss, damages or costs which you may incur or suffer as a result of the delay.
